On April 1, 2025, Atlantic Union Bankshares Corporation ("Atlantic Union") completed its merger with Sandy Spring Bancorp, Inc. ("Sandy Spring"). At the effective time of the merger, Sandy Spring merged with and into Atlantic Union, with Atlantic Union continuing as the surviving entity. Immediately following the merger, SSB, Sandy Spring's wholly owned subsidiary bank, merged with and into Atlantic Union's wholly owned subsidiary bank, AUB, with AUB continuing as the surviving bank. Due to the timing of the mergers and the related systems conversion, the proxy voting records for AUB and SSB are shown separately in the attached Report. The Report begins with SSB's proxy voting record, which is shown consecutively in alphabetical order, begins immediately following Zoetis Inc. with 3M Company and ends with Zscaler, Inc.
