Shareholder Meeting Notice

The Annual Meeting of Shareholders of Union Bankshares Corporation (the "Company") will be held on Tuesday, May 3, 2016 at 10:00 a.m. (Eastern Time) at The Boar's Head, located at 200 Ednam Drive in Charlottesville, Virginia.

Shareholders of record at the close of business on March 9, 2016 are entitled to vote at the Annual Meeting.

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommends a vote **FOR** all nominees listed in Proposal 1 and Proposal 2 and **FOR** Proposals 3 and 4:

1. to elect five Class II Directors to serve until the 2019 annual meeting of shareholders: L. Bradford Armstrong, Glen C. Combs, Daniel I. Hansen, Jan S. Hoover and W. Tayloe Murphy, Jr.;
2. to elect one Class I Director to serve until the 2018 annual meeting of shareholders: Raymond L. Slaughter;
3. to ratify the appointment of Ernst & Young LLP as the Company's independent registered public accounting firm for the fiscal year ending December 31, 2016;
4. to hold an advisory (non-binding) vote on executive compensation; and
5. to transact such other business as may properly come before the meeting or any adjournments or postponements thereof.
